

RENTAL AGREEMENT
Dunk Tank Rules and Conditions
Assumption of Risk and Waiver of Liability

Please read the following carefully before signing

The Undersigned (Applicant), as part of the agreement for use of the Vincent Family Dunk Tank, agrees fully to abide by the following provisions, conditions, and rules, and by signing this agreement acknowledges that they have fully read and understand the following:

1. The Applicant waives and releases Dennis and Anne Vincent, owners, from any and all liability for injury to any person or any property occurring for any reason upon the premises directly or indirectly in connection with the setup, use, and removal of the dunk tank, including any and all claims, actual costs and attorney fees.

2. Dunk Tank participants must be at least 6 years old. If under 18 years old, participants must be supervised by an adult at all times. **Participants must be tall enough so that their heads are above the water level when standing in the tank.** A sufficient number of adults shall be available to control and supervise under-aged participants at all times. **At no time will the dunk tank be left un-attended by adults even if no children are present.**

3. The Applicant is responsible for the use of the dunk tank in an orderly manner and in full compliance with all applicable laws, rules, and regulations. The Applicant assumes full responsibility for the conduct of all persons upon the premises and in the dunk tank. Alcohol, tobacco, and unlawful activity are prohibited with the use of this unit.

4. The Applicant assumes responsibility for damage done to the dunk tank while in his/her possession. The Applicant agrees not to use the tank for purposes other than that for which it was created or rented.

5. The dunk tank needs approximately 300 gallons of water to be used, and will be filled and emptied at the site by the Applicant or authorized persons.

PARTS CHECKLIST

Please verify that the following items are accounted for when returning the dunk tank:

- 2 ea. Stacking boards with brackets attached
- 2 ea. Upper panels
- 4 ea. Lower panels
- Hinged seat
- Target mechanism (square black target attached to 4' rod)
- Target backdrop bracket
- Tank liner (blue)
- Target backdrop (yellow)
- 4 ea. Fluorescent green softballs in black mesh bag

It usually works best to stack the upper panels first on the stacking boards, with the lower panels on top.

The dunk tank is due back by 9:00 p.m., unless previous arrangements have been made. Please let us know if you had any problems with the dunk tank, or if there was anything that could be improved upon. **Thank you!**
